Now comes, Amma Nandi Zulu El Bey, PURSUANT TO: HUMAN RIGHTS AND INDIGENOUS LAWS

United Nations Declaration of the Rights of the Child (1924):

1. The child shall enjoy all the rights set forth in this Declaration. Every child, without any exception whatsoever, shall be entitled to these rights, without distinction or discrimination on account of race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status, whether of herself or of her family... The child shall be entitled from her birth to a name and a nationality.

United Nations Universal Declaration of Human Rights:

Article (15). (1) Everyone has the right to a nationality.

(2) No one shall be arbitrarily deprived of her nationality nor denied the right to change her nationality.

American Declaration on the Rights of Indigenous Peoples (2016):

Article (14). (1) Indigenous peoples have the right to preserve, use, develop, revitalize, and transmit to future generations their own histories, languages, oral traditions, philosophies, systems of knowledge, writing, and literature, and to designate and retain their own names for their communities, individuals, and places.

(2) States shall adopt adequate and effective measures to protect the exercise of this right with the full and effective participation of indigenous peoples.

Article (17). (1) The family is the natural and fundamental group unit of society. Indigenous peoples have the right to preserve, maintain, and promote their own family systems. States shall recognize, respect, and protect the various indigenous forms of family, in particular, the extended family, as well as their forms of matrimonial union, filiation, descent, and family name. In all cases, gender and generational equity shall be recognized and respected.

United Nations Declaration of the Rights of Indigenous Peoples:

Article (5). Every indigenous individual has the right to a nationality...

Article (8). Indigenous peoples have the collective and individual right to maintain and develop their distinct identities and characteristics, including the right to identify themselves as indigenous and to be recognized as such...

Article (9). Indigenous peoples and individuals have the right to belong to an indigenous community or nation, in accordance with the traditions and customs of the community or nation concerned. No disadvantage of any kind may arise from the exercise of such a right.
